Summary	All new University of Phoenix Associate degree alumni students who (i) apply for and enroll in a University of Phoenix bachelor's degree program; (ii) have an aggregate GPA of 3.0 or higher (on a 4.0 scale) in their University of Phoenix associate's degree; and (iii) apply for this Forever a Phoenix [®] Bachelor's Scholarship – June 2024 ("Scholarship") prior to the deadline and register and post attendance in their first class between June 1 st , 2024 and June 30 th , 2024 ("Initial Attendance Window") will have the opportunity to be considered for one of twenty-five (25) scholarships worth up to a maximum of \$2,000 each, distributed over 20 courses. NOTE: Students must begin the admissions application prior to completing this scholarship application.
Application Deadline	The Scholarship application will be made available online on May 1 st , 2024. Applications must be completed and submitted online at www.phoenix.edu by 11:59pm MST June 30 th , 2024 ("Application Deadline"). Applications submitted after the Application Deadline will not be considered. No exceptions.
Eligibility Criteria	 Applicants currently residing in the United States must meet one of the following requirements: be a legal resident of the United States; have been granted permanent residency; have a valid visa that does not prohibit educational studies; have been granted temporary protected status along with approved Notice of Action issued by Citizen Immigration Services and verified through CIS Form g-845; or have been granted asylum along with the approved Notice of Action issued by the Citizen Immigration Services. Applicant must meet all admissions requirements of University of Phoenix if selected as a scholarship recipient. Applicant must not be an employee (including full- and part-time faculty) or a family member (spouse, dependent child, or domestic partner) of an employee of University of Phoenix or any other affiliate of University of Phoenix, Inc. Applicant must subpit a complete, signed application, together with all supporting documentation by the Application Deadline. The completion of the application form does not create an obligation to award a scholarship to the applicant. Selection Process	 The recipients of the scholarships will be selected by the University of Phoenix. It is the applicant's responsibility to submit a complete and signed application along with any required and supporting documentation, which must be received on or before the Application Deadline. The University of Phoenix accepts no responsibility for incomplete applications, applications not in proper form, lost applications, or any other submission in exception to the instructions.
