Applications must be completed and submitted online at www.phoenix.edu by 11:59pm MST June 30 <sup>th</sup> , 2024 ("Application Deadline"). Applications submitted after the Application Deadline will not be considered. No exceptions.					
Eligibility Criteria	<ol> <li>Applicants currently residing in the United States must meet one of the following requirements: be a legal resident of the United States; have been granted permanent residency; have a valid visa that does not prohibit educational studies; have been granted temporary protected status along with approved Notice of Action issued by Citizen Immigration Services and verified through CIS Form g-845; or have been granted asylum along with the approved Notice of Action issued by the Citizen Immigration Services.</li> <li>Applicant must meet all admissions requirements of University of Phoenix if selected as a scholarship recipient.</li> <li>Applicant must not be an employee (including full- and part-time faculty) or a family member (spouse, dependent child, or domestic partner) of an employee of University of Phoenix or any other affiliate of University of Phoenix, Inc.</li> <li>Applicant must apply and be admitted to a University of Phoenix doctoral degree program.</li> <li>Applicant must submit a complete, signed application, together with all supporting documentation by the Application Deadline.
